		Community Noise Metrics (CNM): An engagement session was held to gather community insights on the most important metrics and noise impacts to consider. Further engagement is planned. Metrics will be developed by the NMB and the best way to utilise and monitor these will be considered by the end of the project.	
		Noise Impacts of Late Running Aircraft (LRA): Data analysis is on-going and the project intends to understand the reasons behind why aircraft are arriving in the night despite being scheduled to land during the day.
